Update on EURISCO developments

During 2012, the EURISCO staging area updating has been the major target for development.

The portal is being developed using the Symphony 2 framework (http://symfony.com); this will provide stability and reusability for all components, providing an open-source environment.

The credentials system has been redesigned. The following roles will be available:

- **National Inventory Focal Point:** as before, this provider can upload passport data and it is the only one allowed to update the public portal.
- **Institute:** national inventory focal points can delegate the upload, validation and data quality checks to specific institute data providers, who will be able to upload passport datasets and consult validation and quality reports. They will only be able to see their institute data and they are not able to update the public portal.
- **Dataset provider:** this type of provider is not linked to any specific inventory or institute. He/she will only be able to upload characterization and evaluation datasets for accessions for which the system already hosts the passport data.
- **Curator:** institute or National Inventory Focal Point may delegate the task of curating taxonomy or geo-reference data to other experts in order to improve the quality of the data. The specific privileges of this kind of expert have not yet been fully determined; only its role has been reserved in the system.
- Ontology curator: this expert, who may overlap with any of the above roles, is

responsible for creating and maintaining ontologies.

The ontology management system has been implemented. It will be used to link all dataset data elements to metadata definitions, so that the data dictionary of the system will be shaped by the design of the ontology, rather than the data being shaped into a fixed structure.

- The ontology navigation system has been implemented.
- The ontology creation interface is being implemented.
- The ontology import system (templates, RDF, OBO and OWL) is being designed.
- The data validation system is being implemented. Once terminated, passport data can be uploaded, stored and searched in the system.

The above work covers parts of the *passport staging area* and of the *C&E staging are*. The next step will be the integration of the above components to create a system with the same functionalities as the old one, particularly the ability to upload passport data, receive validation and data quality reports and publish the data onto the public portal. The following step will be the capacity to provide C&E datasets.

The 13th ECPGR Steering Committee Meeting was held at the Federal Ministry of Agriculture, Forestry, Environment and Water Management Austria on 4-7 December 2012. - Update on accessions in EURISCO as part of AEGIS garlic accessions
 The European Collection (AEGIS) is operated as a virtual European genebank. This collection is available in accordance with the terms and conditions set out in the International Treaty on Plant Genetic Resources for Food and Agriculture.
 Currently there are a total of 143 Allium accessions registered in AEGIS by the German and Czech National Inventories.

EURISCO in numbers in 2012

• ITPGRFA in EUROPE: Multilateral System (MLS) registrations in EURISCO

In 2012, the material covered by the MLS of the ITPGRFA, registered through EURISCO, reached almost 23% of the total material listed in EURISCO.

- Altogether, 18 NIs have registered 251,188 accessions in the MLS (see Chart 1 below), representing around 23% of the total material searchable in EURISCO.
- The MLS materials cover more than 65% of the genera from Annex I of the ITPGRFA.




Chart 1 – Percentage of the MLS accessions by NI registered through EURISCO in 2012.

During the period January – December 2012, the EURISCO portal user interface had a total of 8 808 searches.



Site visitors' origin

The "monitoring-of-visitors" log in the EURISCO website provides a good overview of what type of users are looking for information and on what.

In 2012, the traffic of EURISCO site visitors originated from 126 countries, a slight increase from 2010 when the traffic originated from 113 countries.

Summary of facts and figures - impact of changes and improvements to EURISCO:

- As a result of NIs updates, and the consequent EURISCO data refreshment, the total number of accessions increased from 1,096,182 accessions in December 2011 to 1,114,424 in January 2013.
- There was an increase of data providers, from 318 institutes in January 2012 to 332 institutes in January 2013, conserving PGR in Europe.
- The number of species names represented in EURISCO is 34,957 as of January 2013.
- The types of materials searchable through EURISCO include: "wild" 9%, "landraces" 25%, "breeding" 15%, "improved cultivars" 19%, "others" 1% and "unknown" 31% of the total material documented in EURISCO.
- MLS registration in 2012 is 23% of the total EURISCO accessions, covering around 65% of the species from Annex I of the ITPGRFA.
